1. Apologies

Apologies were received from Cllr M Manley, Cllr J Scott and Rev H Reeves. The apologies were accepted.

2. Declaration of Interests

Cllr Mrs Clucas declared an interest in item 5.1 as the family is known to her.

3. Minutes of the last meeting

The minutes of the meeting held on 10 November 2021 were approved and signed.

4. Fees and Charges

4.1 The review of the Burial Ground fees and charges – Cllr Mrs Clucas PROPOSED the following increases to the fees and charges with effect from 01 April 2022.

5. Memorial Garden

5.1 The request for the installation of a plaque without the interment of cremated remains was discussed. Cllr Mrs Connell PROPOSED that, with regret, this request cannot be granted as it would set a

8.2 Waste provision – a site visit with Veolia has been held and they have confirmed that the location of siting the bin where the previous green waste area was is suitable. As soon as credit checks have been completed, the bin will be delivered.

8.3 It was NOTED that there are moles in the Burial Ground.
