The proposed extension would result in an unacceptable loss of light to the ground floor kitchen window of number 3 Billet Cottages and would thus fail to comply with Policy EN2 of the Sevenoaks Allocations and Development Management Plan The site is located in the Metropolitan Green Belt where restrictions on development apply. The property has already been previously extended and the cumulative additions, including the proposed extension, would result in an uplift over 50% of the original dwelling. The proposed addition would therefore result in disproportionate additions to the dwelling constituting inappropriate development in the Green Belt by definition resulting in material harm to the openness of the Green Belt contrary to Policy GB1 of the Sevenoaks Allocations and Development Management Plan and National Planning Policy Framework.
